Coach education dates are getting finalized for early spring in Cheyenne and possibly Evanston for some free coach education. We are looking at D license dates for late spring and also in the summer. Also we have applied for Wyoming to host a C license class late summer.

**District 3:** Annie Fletcher - verbal report. Not much to report. Rock Springs soccer board met and they would like to know where the state stands on the merger between the rec league and competitive league and what the states stance on this is. Dan suggested Lisa and Jeff help facilitate this. We will help and assist in any way to pull together as one group in Rock Springs. Dan has volunteered to be a mediator between the two organizations if they would like or he would help find someone to help in this process as well as fund this person to travel and help in this process. The Avengers have a new president - Mike Bolten.

**District 4**: Fabian Lobera - verbal report. Travel and competitive registrations are up in Casper. For the first time - 100% of our competitive coaches are licensed through USSF. 420 players in the academy (rec program). Fall Classic was a huge success with really only one issue that the board had to meet for in regards to one particular game. The state can not take action until/unless a written report is submitted to the WSA office. No updates from Douglas. Lander/Riverton are both doing a great job - they have passionate and progressive boards. Lander has a 161 competitive players and they are also working on bringing the rec and competitive programs together. There will be a 3rd Annual Wind River Classic. They had 63 teams and they are curious of any grants that may be available for field work. They have been lenient for players who have wanted to play on academy or DA programs as guest players however they have a lot of players joining other small towns because they are unhappy with their current situation and they would like some guidance on how to deal with situations like this. Guest playing simply because they are unhappy with a coach is not in the clubs best interest. Riverton's board is getting stronger every day. They are a young board and we as a state need to to support and recognize the good work they are doing. They would also like some type of ref/parent education and Fabian is working on putting something together.

**Adult Committee:** 

**Bylaws and Policy:** Trying to recruit some new members to the committee. Jeff does have one issue he would like to bring to the board. It has been discussed to add two positions to the board, a youth and adult league player to the board, as well as another member at large. These ideas have been discussed. Jeff would like to know if this is something we should pursue. We already have a problem getting members to attend and

having a quorum so he is reluctant to add more members. Also has been discussed to have them be non-voting members. Discussion held. The reason to add these positions was to get player input on the board - the additional member at large position was suggested so that we could have an additional professional on the board. This could provide an opportunity for development of a young player and that could be really beneficial. Jeff will move forward and discuss with Dan different options. Regarding discipline issues at tournaments; it isn't very clear on how the state gets involved. It is important to send this information out to our leaders in the state so they know how to address these situations.

**State Referee Committee**: Roger Brown. SYRA attended region IV meeting last week to discuss post season events. Coming from USYS they want to change direction as to what events we are sending referees to. ODP in the future will be handled by AZ referees only we will not be required to send referees. There is really no future development from that event because it is a single event. We will continue to send to Far West and Presidents Cup - one referee per team attending. There is talk of a new event in 2021 where they have the National Teams play. They are trying to develop referees at these events and they can earn rights to go on to the National events by performance. This year - we will not send referees to ODP Championships in January but we will send referees to Far West and Presidents Cup based on how many teams attend. Still working on getting all referees certified in Safe Sport and that will be in with their recertification for this next year. All the registration links will be up by Nov 1st.

## **Old Business**

**WSA Communication Policy:** New policy submitted (attached). There was concerns with the verbiage in the social media section. Per Jeff our policy states we follow all USYS rules policies and procedures. Dan would like to remove the social media piece. Jeff would like to go through the whole document USYS has and compare with ours and if they are the same we can adopt their policy and post it on our website. He said that he will have this done by the next board meeting. Fabian would like to see this ahead of time so that he can read over it prior to the next meeting. Tabled for now.

## **New Business**

**CPA/Accounting Services Quotes:** We have looked at outsourcing our accounting services. We went out to 3 different accounting firms. We received quotes from 2 of them, one of them is Above the Line which is Jason Howells firm and also Skogan which is the firm who does our tax return every year. The two quotes are for the same services. Above the line is in for \$18000 with Tax return and Skogan came in at \$32500 with tax return. The Skogan

account could fluctuate monthly - we did take the high amount. Even with the lower number Jason's firm is still the lowest. Dan's recommendation is that we put on the floor a motion to approve outsourcing our account services to Above the Line CPA for \$18000/year. Jeff motion to approve Above the Line as submitted. Roger second. Discussion held. All in favor. None opposed. Motion approved as submitted. (Jason Howell Treasurer obtained from vote.)

**Wyoming 307 Select Rule Change:** See attached. Jeff motion to approve as submitted. Fabian second. No discussion. All in favor. None opposed. Motion approved.

## **Communications & Social Media**

- WSA Administrators and Staff are required to reply to electronic communications from members within 72 hours.
- In the event an administrator or staff is out of the office for an extended period of time, a reply is expected within 72 hours of their return
- An "out of office" automatic reply shall be set up in the event an administrator or staff of WSA will be away from their office for more than one business day.
- Application for the remainder of this policy
- The remainder of this policy applies to WSA and each member and affiliated club as defined above in "Definitions".
- Administrators will be collectively referred to as Adults throughout the remainder of this policy.
- Communications between adults and minor athletes
- All electronic communication originating from Adults to minor athletes must be professional in nature.

- If an adult needs to communicate directly with a minor athlete via electronic communications, another adult, preferably the minor's parent(s) or legal guardian will be copied.
- If a minor athlete communicates to an adult privately first, the adult should respond to the minor athlete with a copy to another adult, preferably the minor's parent(s) or legal guardian.
- An adult communicating electronically to the entire team will copy another adult.
- Prohibited electronic communications
- Adults are not permitted to communicate privately via electronic communications with minor athletes.
- Adults are not permitted to "private message," "instant message," "direct message," or send photos privately via Snapchat, Instagram or any other social media platform to a minor athlete.
- Adults are not permitted to maintain social media connections with minors.
- Adults are not permitted to accept new personal page requests on social media platforms from minor athletes, and
- If social media connections with minor athletes existed prior to WSA membership, the connection shall be discontinued.
- Requests to discontinue
- Legal guardians may request in writing that their child not be contacted through any form of electronic communication by WSA or its member or affiliated clubs, or by any adults from those organizations.
- The organization (WSA or an affiliated member) will abide by any such request that a child not be contacted via electronic communications, absent emergency circumstances.
- Monitoring
- WSA and its member and affiliate clubs will monitor their social media pages and remove any posts that violate the organization's policies and practices for appropriate behavior. This includes, but is not limited to use of foul or otherwise offensive language, inappropriate or offensive photos, sharing of personal or private information or unsolicited content from businesses or individuals.
- If WSA or one of its member or affiliate clubs finds that a minor athlete has
  made a prohibited post on the organization's social media site, the
  organization will notify both the minor athlete's parents or legal guardian of
  the prohibited post, and the affected organization's primary executive officer.
- WSA reserves the right to remove any post or comment from their organizational social media platforms and/or block users for any reason without notification.

# Player Permission Requests & Rules (Page 4)

3) Players are primary to their club team and are obligated to participate with that team in any team event, tournament or game the team has entered into at least 8 weeks in advance of the event date.

# RATIONALE

This change is proposed in order to simplify the language and accurately reflect the spirit of the rule.
